# **Library Movie Theater Burns**

On Monday, August 19, 2024, the original Park Theater was engulfed in flames. The fire was battled for more than two hours and as pictured below had as many as four ladder trucks dousing the heavy flames from multiple angles. The building debuted as the "Park Theater" and in 1948 was the venue for the



movie premiere of "Miracle of the Bells". Vacant for many years the theater was most recently known as the Ruby Daugherty School of Dance. The cause of the fire is still under investigation and as pictured below, it appears to be a total loss.

#### Yard Caves In Under Woman

#### Wife of Library Striker Falls 20 Feet Into Entry Room of Montour Mine.

Mrs. Anne Hadalin, of Library, was recovering yesterday from the shock of falling 20 feet into a mine entry room of Montour mine No. 10 of the Pittsburgh Coal Company when the earth in the yard of her home gave way.

Mrs. Hadalin, wife of a striking miner, was raking her garden when the ground collapsed and precipitated her into the darkend entry, where she was imprisoned for nearly an hour before her cries attracted the attention of John Humes, fire boss at the mine.

Humes, with the aid of other miners, cleared away the dirt and brought the woman to the surface.

#### Dynamite Rocks Library Lanes

A Library bowling lane was damaged heavily in an explosion and fire today but damage could have reached into the town itself if 12 unexploded sticks of dynamite set in the apparent arson attempt had gone off, authorities believe.

South Park Twp. Police said a loud explosion in Parkside Lanes, at the intersection of Brownsville Road, Route 88 and Library Road, rocked the community about midnight, causing upwards of \$75,000 damage.

Firemen from Broughton and Library battled the flames for about two hours before bringing them under control, then found the unexploded dynamite, and about 200 gallons of gasoline in 50-gallon drums, scattered about the building.

An Army demolition team from Irwin, Westmoreland County, was summoned to dispose of the explosives.

One of the demolition experts estimated half of the town of Library could have been destroyed had the 12 remaining dynamite sticks exploded. He estimated two sticks had exploded.

State police fire marshals are cooperating with the township police in an investigation.

Damage to the bowling establishment was estimated by firemen at \$75,000 to \$100,000.

# Dynamite Is Found After South Park Fire

After South Park Township firemen doused a blaze at the plant which manufactures Grandma's Pirogis, 4120 Brownsville Road, they found 14 sticks of dynamite and nine intact 35-gallon gasoline drums in a bowling alley on the first floor.

Theodore L. Hale, chief of the Library Fire Co., said he also found three burnt gasoline drums in the Parkside Bowling Lanes, which was gutted.

Part of a wall exploded at 12:50p.m. Sunday and a gas water heater was blown out of the building several feet, unleashing a steady flow of natural gas from a three-quarter inch pipe, Hale said.

While part of the crew battled the flames, another crew searched for the valve to shut off the gas.

"We didn't even find the dynamite and gasoline drums until we put the fire out and put in the exhaust fans to blow out the smoke," Hale said.

Only one minor injury was reported. Howard Barr, a fireman with the Broughton Fire Co., stepped on a nail and was treated at St. Clair Memorial Hospital.

The two-story building, located about 50 yards from the intersection of Brownsville Road, Route 88, and Library Road, also housed a Scott Oil Co. gas station, a laundromat and Grandma's Kitchen food Co.

Andrew Levitske, one of the owners of the building, said yesterday he had no idea where the dynamite and gasoline came from.

A two-man U.S Army demolition team from Irwin, Westmoreland County, went to the scene at 5:30 a.m. to dispose of the explosives. Hale said the gasoline drums and the dynamite were scattered through the 16-lane bowling alleys. Although the building is primarily a steel, brick and concrete structure, wooden partitions on the first floor fueled the fire, Hale said.

The two South Park Township fire companies from Broughton and Library fought the fire with a Bethel Park fire company. State police fire marshals and township fire and police officials were investigating last night.
